- MEDIA: All media accepted: 2D, 3D, 4D; if mixed media, be specific.
 Juried by jpegs
- SIZE LIMIT: 72" in any direction.
 Artist needs to be present to assist with
 the installation of large or awkward sized
 work. Artist should check with ARC.
- WORK MUST BE READY TO HANG or work will not be hung.
- ARTISTS RESPONSIBILITIES: ALL shipping costs and return shipping arrangements and cost; and insurance.

EXHIBITION THEME

SAVE JPEG AS: RGB Color Size your images no larger than 1920 pixels x 1920 pixels. Your jpgs should be under 2 megs each.

DELIVERY of ACCEPTED ART

If you are shipping your work: All art work must be delivered to ARC by Federal Express, UPS or another shipping company at your cost. We do not recommend using the U.S. Post Office as ARC has experienced difficulty with past postal deliveries. Note that ARC does not have the personnel to go to the Post Office to pick up undelivered, registered or certified mail or to remove crates from a shippers' truck. The artist is responsible for any special delivery instructions or arrangements. Please remember to inform the shipper of the gallery hours. (Wed. thru Sat. 12-6:00 pm; Sun. 12-4:00 pm)

All artwork must be at ARC Gallery by Friday, January 29. Do Not use packing peanuts in any of your packages.

Each artwork must have a label on the back with the name of the artist, title of the artwork, and phone number.
