Call for Curatorial Proposals:

CAA invites curators to submit proposals for exhibitions whose openings coincide with the 2010 Annual Conference in Chicago. Exhibition must be held in the conference city and on view during the conference dates: February 10-13, 2010. Deadline: September 1, 2008.

There are no limitations on the theme or media of work to be included in the exhibition, except that it must be a group show of contemporary art, comprising about fifteen artists. CAA's Exhibitions Committee reviews and evaluates proposals based on merit. CAA provides support for the exhibition with a grant of up to \$10,000. An additional grant of \$5,000 is available for an exhibition catalog to be printed in sufficient numbers for distribution to all Annual Conference attendees. Preference is given to those proposals that include both an open call and some CAA members among the exhibiting artists. Proposals must be submitted by e-mail and should include the following information:

• Name(s) of curator(s) or organizer(s), affiliation(s), and CV(s)

• A brief statement of 250 words or less describing the exhibition's theme and explaining any special or timely significance it may have.

• Identification of the designated venue, including a brief description of the exhibition space, its staffing and security features, and the approval for this exhibition by the venue's appropriate officer or authority; a space of no less than three thousand square feet is highly recommended

• A detailed exhibition budget for expenses and income, showing other anticipated sources of funding or in-kind support

Transportation:

Washington DC Area is served by many airlines at three airports: Reagan National (DCA) in Washington DC, Dulles (IAD) (23miles from National Airport in Virginia), and Baltimore Washington (BWI) between Washington DC and Baltimore (27 miles from National Airport).

There are taxis at all three airports. However it may be VERY expensive to take a taxi or shuttle from Dulles and Baltimore Washington airports because they are so far from the Washington Area.

There is a Metro stop at National Airport. Dulles and Baltimore Washington airports both have shuttles to the Metro. Sharing a taxi (if going to the same destination) or taking a cab from the Metro closest to your destination may be cheaper.

## Update (as off June 4, 2008):

On Saturday, May 31, the Illinois General Assembly approved a state budget for FY2009 and adjourned for the summer. The budget restores \$3.5 million of the \$4.5 million cut from the Illinois Arts Council's budget in FY2008. It also appropriates \$4 million for the Arts and Foreign Language Grant Program through the Illinois State Board of Education. Funding for the Grant Program was eliminated in FY2008. The budget is a step in the right direction, but we haven't crossed the finish line yet.

In a press conference on Monday, June 2, Governor Rod R. Blagojevich announced that the budget passed by the General Assembly has a deficit of \$2 billion and is unconstitutional. "The state constitution requires that the legislature pass a balanced budget," said the governor. "I have in my possession a budget that is out of balance. I think it's fair to say that the legislative process ought to continue, and we do not have a budget for the state of Illinois."

The governor is meeting with the legislative leaders of the General Assembly ~ Speaker of the House Michael Madigan, Senate President Emil Jones, House Minority Leader Tom Cross, and Senate Minority Leader Frank Watson ~ this week to discuss the budget further.

As deliberations on the budget continue, it is essential that Illinois legislators hear from you about the importance of the arts and arts education to the cultural, educational, and economic vitality of our state.

#### National Endowment for the Arts

The House Interior Appropriations Subcommittee, which sets the initial funding level for the National Endowment for the Arts (NEA), approved a \$15.3 million increase for the NEA in its FY 2009 spending bill. Chairman Norm Dicks (D-WA) has once again proposed an increase in funding for arts and culture in the face of a dramatic cut proposed by the president's recent budget.

Currently funded at \$144.7 million, this increase would bring the agency's budget to \$160 million. President Bush requested a cut to \$128 million for the NEA for FY09 from the current \$144.7 million level. On Arts Advocacy Day, Americans for the Arts presented a panel of witnesses before Chairman Dicks' Appropriations Subcommittee calling for a significant increase in funding for the NEA. Witnesses included actor/director Robert Redford, musician John Legend, and actor Kerry Washington. Next Steps:

The FY 2009 Interior Appropriations bill will next go to full committee and then to the House floor for final consideration where your help may be needed to defend against floor amendments attempting to cut this increase. We must now put pressure on the Senate to match this funding level. Please take two minutes to visit:

## VOLUNTEER OPPORTUNITIES

For the first time we had a female presidential candidate, a female Secretary of State and a female Speaker of the House. There are 13 women around the world who are elected heads of state. Women are now CEO's of big corporations; there are women generals in the service and more than 200,000 women in the service. But, we still lag behind males in our earning capacity. In the art world there are more and more women curators in art museums and many more women exhibit in galleries than years ago. The Museum of Contemporary Art hired Madeleine Grynsztejn in the position of Director just recently.

WCA was founded to help fight for women's rights in the art world and to educate the public about the contributions of women. Now more than ever we feel we must keep women's art organizations going. Therefore, we are appealing to all of our members to make CWCA as viable, helpful, and useful as possible. We need you to volunteer and participate in our programs and events.
